

# Hosei Business School of Innovation Management Global MBA Program 2020 Enrollment Information for Non-degree Students

Those who wish to take courses at this graduate school are permitted to take courses as “non-degree students” after a screening process, provided there is sufficient class capacity, according to Article 47 of the Professional Graduate Schools Regulations. Non-degree students may only take courses on which regular students are registered.

### 2 Number of credits that can be taken: Up to 20 credits per year

※ Article 6 of the Graduate School Non-degree student Regulations is not applicable.

※ Please note that the following subjects are not available for enrollment:

Project1-A, Project1-B, Project2-A, Project2-B, Strategic Organizational Management  
Multinational Business I and II

※ Enrollment for non-degree students may also be restricted for subjects other than the aforementioned ones, depending on the enrollment status of the regular students taking the course.

### 3 Application period:

( 1 ) March 16 (Mon)–March 23 (Mon), 2020 (Registration for courses starting in the spring semester only)

( 2 ) June 22 (Mon)– June 29 (Mon), 2020 (Registration for courses starting in the summer intensive period only)

( 3 ) July 27 (Mon)–August 3 (Mon), 2020 (Registration for courses starting in the fall semester only)

### 5 Qualifications for application:

**Applicants must satisfy the following qualifications “a”–“c.”**

#### a. Professional qualifications (any one of the following as of April 1, 2020):

[1] Generally, those who have at least three years of practical experiences at private companies, government agencies, public interest corporations, etc., including those located overseas.

[2] Those who are recognized by this graduate school as having the same or higher level of practical ability than those who have at least three years of practical experiences through individual examination of application qualifications.

#### b. Academic qualifications (any one of the following)

[1] Those who have graduated from a 4-year university course in Japan or abroad, or those who are expected to graduate by the end of March 2020.

[2] Those who have completed 16 years of school education abroad or those who are expected to do so by the end of March 2020.

[3] Those who have reached the age of 22 and whom this professional graduate school recognizes as having equal or higher academic ability than those who have graduated from university through individual examination of application qualifications.

[4] Those with other qualifications that this professional graduate school recognizes as constituting at least the same academic ability as those who have graduated from university.

c. English language ability (any one of the following)

[1] TOEIC® score of 740 or higher

[2] TOEFL® score of 81 (internet) , 553 (paper test) or higher

[3] IELTS™ score of 6.0 or higher

※ If you are interested in having your application qualifications individually examined, please contact us for the spring semester by the end of February, for the summer intensive period by the end of April, and for the fall semester by the end of June.

Note 1: Graduates of this school are exempted from the submission of documents that are marked with an asterisk (\*).

Note 2: If you wish to enroll more than once within the same year, you can omit the documents other than the application form during the second time you apply.

7 Tuition fees:

( 1 ) Registration fee

10,000 yen

※ You do not need to pay the registration fee for the second time if you wish to take several courses within the same year.

※ You do not need to pay the registration fee for the second time if you are taking courses in other majors within the same year.

※ Graduates who have majored in Innovation Management are exempted from the registration fee.

( 2 ) Course fee (for one subject [two credits]): 150,000 yen; (one subject [four credits]: 300,000 yen)

※ Graduates who have majored in Innovation Management pay half of the above amounts.

8 Permission to study and payment of course fees:

Those applying for the spring semester subjects will be notified as to whether their applications were successful in late April; those applying for summer intensive courses will be notified in late July; and notifications regarding fall semester subjects will be sent in late September. Notifications will be sent to the current address listed on the resume. If you have been accepted to take the course, please use the designated form for bank transfers within the period specified in the course approval notification.

※ **Please attend classes from the first lecture onward regardless of whether you have received permission to study from the Hosei Business School of Innovation Management.**

9 Issuance of accreditation of credits and certificates:

Non-degree students can take exams for the subjects they have opted. If you pass the exams, you will be certified as having taken the course subjects (units), and we will issue a certificate upon your request.

10 Visas for international students:

When applying as a foreign student to the non-degree students system of this graduate school, students must generally have a visa that allows them to stay or renew their stay in Japan for a period longer than the period they are enrolled in this school as a non-degree student (until the end of September 2020 for the spring semester and until the end of March 2021 for the fall semester).

Please be noted that this graduate course will not enable students to acquire a study abroad visa even for those accepted as non-degree students for either of the following reasons:

① Non-degree students may apply for up to 20 credits at this graduate course, but if, as a result of individual examination of a prospective student, permission to take one or more subjects is not granted, a student cannot study “10 hours or more per week” (six or more subjects) as stipulated in the “Ministry Ordinance to Establish Criteria for the Immigration Control and Refugee Recognition Act, Article 7, Section 1, Item 2” (Ministry of Justice Ordinance), then a student visa cannot be obtained (or renewed).

② Even if all the subjects applied for are approved, all of our admission procedures will be completed by early May for the spring semester, by early August for the summer intensive period, and by early October for the fall semester. It will then take approximately from one to two months from the visa application until the visa issuance, and the student visa will expire at the end of each semester when classes end.

11 Approval of credits after admission:

If you are enrolled at the Hosei Business School of Innovation Management, non-degree students are authorized to take up to 20 credits of the Hosei Business School of Innovation Management. However, while the 20 credits will be evaluated as R (accredited) and converted to completion credits, they will not be eligible for GPA or scholarship assessment.
